President's Report (Brian Hasenbauer):

T-SHIRTS: Brian and Judy compared and corrected the t-shirt inventory. Only gray shirts will be maintained in the future. The t-shirts will be displayed and sold at the May Picnic. They are also available for on-line purchase.

MAY PICNIC: Preparations for the May 15 picnic event are underway. RSVP's are being accepted. Vice-President Kendall Scudder has prepared a candidate/elected official list for picnic RSVP's.
